May be used for mounting photographs, printed materials, artwork, labelling, lining shelves with paper, for sticking foils, cardboard, cork, felt, rubber and polyurethane foam, fiberglass, upholstery, fabrics and many other household materials. SURFACE PREPARATION

Ensure all surfaces are clean and dry.

APPLICATION

Shake can well before use. Spray adhesive 20cm to 25cm from material to be bonded.

NON POROUS SURFACE: Spray both surfaces and allow approximately 2 minutes, then press together.

FOR A TEMPORARY BOND: Spray only one surface and allow about 5-10 minutes before bonding.

AFTER USE: Always clear the nozzle by turning the can upside down and spraying away from you for a few seconds to prevent clogging. Clean overspray or spray nozzle with cloth dampened with mineral turps immediately after application.

CLEANING

Always clear the nozzle by turning the can upside down and spraying away from you for a few seconds to prevent clogging. Clean overspray or spray nozzle with cloth dampened with mineral turps immediately after application.

STORAGE AND SHELF LIFE

Store in a cool dry place below -5 to 25° C and out of direct sunlight. Shelf life is 12 months from the date of manufacture when stored as directed.
